Introductory Lecture: Understanding internationalization

The debate about internationalization has become politicized and may have become part of discussions on immigration, (de)globalization, sustainability, inequality, identity. General added-value arguments or cost-benefit analyses are no longer sufficient for HEIs to defend their stance. For proper arguments, consistent with their academic mission and values, a better understanding is required of both the internal differentiation and the external dynamics of internationalization. A new conceptual approach provides a deeper insight into the differences across disciplines and professional fields within universities on the one hand, and the structure of labour markets on the other.

Group discussion on internal differentiation in relation to one-size-fits all policies, academic values, public opinion, and political arguments.

Team work: Exploring the model in relation to participants' own experiences, practices, and institutions. And the consequences for cross-institutional and cross-disciplinary collaboration, mobility, and university strategy.

Tuesday 22 August

Lecture: The impact of geopolitical developments on higher education institutions

The changing global context implies geo-political, demographic and technological shifts. Tensions between Global North and Global South, conflict and war on the Eurasian continent, and a changing role of the EU. How do consequent de- and re-globalization, regionalization, rise of nationalism, protectionism, technological challenges, and enhanced security concerns affect higher education in general and its global mission and international actions in particular?

Group discussion on the challenges that universities face in defending their mission and values in relation to boosting technologies, narrowing regulatory frameworks, and enhanced risk.

Team work: analyzing the changing context and its impact on universities; are they leaders or followers?

Changing relations between China and Europe: comparing perspectives and (mis)conceptions
